With today's pressing issues in America, it is imperative that we recognize and preserve the historical content that is within the Civil Rights District in Birmingham, AL. This district is where great Civil Rights leaders such as Rev. Frederick Shuttlesworth, Dr. Martin Luther King Jr., and others confronted segregation with the drive to dismantle and eliminate it through nonviolence.

The proposed park is home to the historic A.G.
